Your proxy will be entitled to vote at his discretion on any resolution properly put to the SGM other than that referred to in the notice of the SGM.
- 5. This form of proxy must be signed under the hand of the appointor or of his attorney duly authorised in writing, or if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised.
- 6. If two or more persons are jointly entitled to hold an ordinary share and are present at the SGM, only the joint holder whose name stands first in the register of ordinary shareholders of the Company in respect of the joint holding is entitled to vote at the SGM.

To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of that power or authority, must be deposited with the Company's branch registrar in Hong Kong, Tricor Tengis Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, not less than forty-eight (48) hours before the time appointed for the holding of the SGM or any adjournment thereof.
